Although not yet final, the recently released criteria give physicians a better sense of what their EHR systems will need to be able to do come 2011. The CMS proposed rule will likely be released for public comment in December 2009, and will have an associated 30 or (more likely) 60 day public comment period.

Hospitals and physicians are faced with “meaningful use” incentives focused upon implementation of the electronic medical record. The year-one meaningful-use criteria for physicians (hospitals have separate criteria) fall under five areas. Hospitals criteria: AHA recommended six additional functions for EHRs be added to the 2011 rule.

Antimicrobial resistance is a growing problem in many hospitals. Many nosocomial infections result from pathogens that are in many cases resistant to two or more commonly used antibiotics. This makes empiric selection of appropriate antibiotics difficult; however, delaying therapy until microbiological results are available leads to increased mortality and morbidity. Antimicrobial stewardship can help reduce antibiotic pressure which decreases resistance. A rapid and reliable health information management is essential for an effective antimicrobial stewardship.
